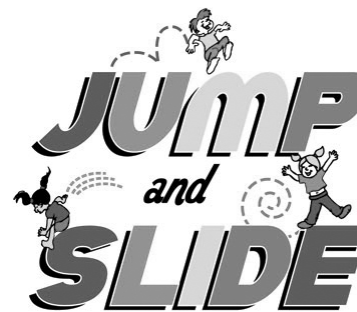

RELEASE AND ACKNOWLEDGMENT OF RISK

- I understand and acknowledge that the activity to be engaged in through my rental of any equipment brings with it both known and unanticipated risks to myself, guests and others. Those risks include but are not limited to falling, slipping, crashing and colliding which could cause injury, illness, disease, death, and/or property damage to my guests, myself or others.
- I voluntarily release, indemnify, hold harmless and discharge Jump and Slide, Inc. (hereinafter referred to as JSI) for any and all liability claims, demands, actions or rights of action, whether personal to me, or a third Party, which are related to, arise out of or are in any way connected with my rental from JSI including those allegedly attributed to negligent acts or omissions. I agree to reimburse any reasonable attorney's fees and costs which may be incurred by JSI in any defense of any such liability claim, demand, action or right of action.
- In the event, I file a lawsuit against JSI, I agree to do so solely in the state where the JSI office is located, and I further agree that the substantive law of that state shall apply in that action without regard to the conflict of law rules of that state.
- I acknowledge that I have adequate homeowners, tenant or other liability insurance to cover any injuries or property damage which might occur to myself, guests or others while using the equipment rented from JSI.
- I acknowledge that I am responsible for the safe keeping of the rental equipment while in my possession. **In the event of damage to (other than normal wear and tear) or loss of the equipment occurs while in my possession, I will promptly reimburse JSI for replacement or repair.**
- **I have read the rules supplied by JSI regarding the use and installation of the rental equipment and agree to follow these rules without exception.**
- **I acknowledge and certify that I have had sufficient time to read this entire agreement, understand the content and freely execute it without duress. I agree to be bound by the terms of this agreement.**

1. **Supervision by a qualified attendant is required at all times** _____
2. **Ride MUST be securely tied down (see Set-up Instructions)** _____
3. **Blower requires a GFCI circuit (see Set-up Instructions)** _____
4. **Keep children away from the blower at all times** _____
5. **DO NOT USE, and immediately deflate in high winds** _____
6. **Persons with mental or physical impairment SHOULD NOT use the ride** _____
7. **REMOVE shoes, eyeglasses and any sharp objects** _____
8. **NO food, drinks, gum, pets or SILLY STRING** _____
9. **Somersaults, diving, wrestling, rough play & flips are prohibited** _____
10. **Play away from others and away from the sides and entrance/exit** _____

PICKUP AND SAVE CUSTOMERS ONLY

1. **Additional rental fee applies when not returned by 3pm of scheduled day** _____
2. **Customers requiring JSI to pickup rides will be charged an additional fee based on distance and difficulty (minimum \$50)** _____
